



If you plan to get married in a foreign country, you may be asked to obtain a letter from the Idaho Bureau of Vital Records and Health Statistics confirming that a diligent search of Idaho's marriage and divorce records that have been filed since May 1947 has been completed. Some agencies refer to this letter as a Certificate of Non-Impediment or a Single Status Letter.

To request this letter:

- Complete the application on page 2 of this document to request a search of Idaho marriage and divorce records from May 1947 to the present.
- Once the search is complete, we will issue a notarized letter certifying the results of the search.

Important Notes:

- **We can only search records of marriages and divorces that occurred in Idaho.**
- For records from other states or U.S. territories, visit <https://www.cdc.gov/nchs/w2w/index.htm> for contact information for their vital records offices.
- If you need the letter forwarded to the Secretary of State for an Apostille there will be a \$10.00 Apostille routing fee payable to Idaho Vital Records. This service does not include fees charged by the Idaho Secretary of State.
- If you need an Apostille please include the completed application and \$10.00 per document payment made payable to Idaho Secretary of State with your request. Please see their website for fees and instructions: <https://sos.idaho.gov/apostille/>.
