Subject: Change in Reimbursement for Residential Habilitation (ResHab) Services

The table below summarizes the changes to reimbursement rates for Home and Community Based (HCBS) services rendered by an approved rendering provider. **These transitional rates will be effective in the MMIS system November 3, 2022, for dates of service July 1, 2022 forward** (and posted to the [Idaho Medicaid Numerical Fee Schedule](#)). Claims for dates of service on and after July 1, 2022 that have already been processed to paid status will be automatically reprocessed to account for the updated reimbursement rate. Most providers do not need to take additional action. Some Prior Authorizations (PAs) for some providers had to be reissued. The new PA numbers have been established. Claims billed after July 1, 2022, with a newly issued PA number will need to be reprocessed by the provider with the new PA number on the claim. Claims reprocessing activities for claims without a newly issued PA have been completed. Providers should continue to submit claims with their usual and customary charges.

Claims submitted to a managed care vendor, including Blue Cross of Idaho and Molina Healthcare of Idaho, will also be automatically reprocessed. Claims reprocessing activities are expected to begin November 21, 2022. Providers do not need to take additional action. Providers may submit claims for dates of service on and after July 1, 2022 to these managed care vendors using the rates reflected below once the managed care vendors have configured these new rates in their claims systems. These rates are expected to be effective in each vendor's claims system on or around November 21, 2022. Each vendor will communicate this date to its provider network.

While these rate increases are ongoing, the Division notes that once programmatic changes are implemented within the next year, providers may see a difference in reimbursement. These programmatic changes include unbundling of the Residential Habilitation reimbursement and implementation of new services. Providers may see this difference based on their billing and provision of these new services and the unbundling from a per diem rate.

The tables below summarize the upcoming changes to reimbursement rates for Home and Community Based (HCBS) services rendered by an approved rendering provider. These rates will be effective upon approval by the Centers for Medicare & Medicaid Services (CMS) and are anticipated to go live within the next year. Once approved, these codes and rates will be posted to the [Idaho Medicaid Numerical Fee Schedule](#) and will replace the transitional rate updates listed in the tables above.
